

# Local development in EU funds today

### Pillar I: Single Plan for each Member State

Around **530 programmes** for Member States (2021-2027 MFF)

 Cohesion policy: 398 (national and regional programmes + 27 partnership agreements

27 programmes for all Member States

- Agriculture and fisheries: 54
- Home funds: 79


## **Territorial dimension in 2021-27**

Compulsory urban allocation increased from 5% to 8%

New category "other tools": e.g. domestic approaches in line with key principles

Uptake:

- €40 billion Cohesion Policy funding implemented through territorial instruments\*
- ITI: broadly continuation and often expansion (CZ, PL, HR)
- CLLD: mix of introduction (RO, FR, EE), continuation (BG, CZ, SI) and discontinuation (PT, SE, SK) – see map

## Recently...

- Commission's Communication: "The road to the next multiannual financial framework" (11 February 2025)
  - "Status quo is not an option"
    - Public consultation: 12 February 7 May 2025
      - Over 2500 responses received
      - Common civil society position (e.g. minimum 50% total budget on sustainability, climate and environment)
  - European Parliament's priorities (7 May 2025)
    - 'Single national plan' approach cannot be the basis for spending in MS
    - Mega-funds merging existing programmes are not fit for purpose



• Commission's proposals expected in July 2025
